

# NE14 TENNIS FANTASY TENNIS COMPETITION 2021

## TERMS AND CONDITIONS

1 Fantasy Tennis is an online fantasy sports community and game of skill. For the purpose of this promotion the following definitions apply:

“Promoter” means NE14 Tennis.

“Promotion” means the Fantasy Tennis competition, conducted during the course of the 2021 ATP & WTA Grand Slam & Season Finals.

“Promotion Period” means the period commencing at 12.01am Greenwich Mean Time (“GMT”) on 3 February 2021 and closing on 11.59pm Greenwich Mean Time (“GMT”) on 23rd 10th December 2021. Entrants are responsible for determining the corresponding time zone in their respective jurisdictions.

“Website” means [www.ne14tennis.co.uk](http://www.ne14tennis.co.uk).

2 Information on how to enter form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. In the event of any inconsistency, these Terms and Conditions shall prevail. The laws of United Kingdom apply to this Promotion to the exclusion of any other law, except to the extent that such laws cannot be excluded. Participants submit to the exclusive jurisdiction of the courts of United Kingdom.

### Eligibility to Enter

3 Persons who are:

- 18 years old at the date of entry.
- Participants under 18 years of age (except in France where Participants under 18 years of age are not permitted) must have the consent of a parent / legal guardian to enter the Promotion.

All Participants consent to the publication of their first name and nickname/alias in all rankings on the Website.

### **Entry**

4 Participation is free of charge except for any costs that may be incurred under the contract between the participant and his/her telecommunications provider. To enter, the Participant must firstly register by completing the online registration process at the Website during the Promotion Period. This will require the Participant to provide the following details:

- name, email address, phone number, date of birth

Participants will be required to (a) choose a teamname to identify their entry; (b) subject to “Squad Budget” as detailed on the Website, submit a complete team of 8 tennis players competing in the event. This will be made up of 4 Male and 4 Female Professional Tennis Players (“Chosen Team”).

5 Only one registration per Participant (and per email address) may be submitted. Under no circumstances can Participants enter two or more registrations or team entries. Any Participants found to do so will be disqualified.

### **Rules**

6 Participants are able to replace players in their Chosen Team via the “Enter Team Page” on the Website, in accordance with any directions.

7 After each tournament deadline, there are no amendments to any entries.

- 8 Participants will score points based upon the performance of their selected players in their team. Points will be awarded (or subtracted) for each performance statistic attributed to that player during the tournament as follows:

### **Match Points**

Aces = 1 point per ace

Winners = 1 point per winner

Double Faults = -2 points per double fault

Unforced errors = -1 point per unforced error

### **Match Bonus Points**

Match Won = 20 points per match

Straight Sets Win = 10 points per match

Sets Won by 3 games or less. (e.g. 6-3, 6-4, 7-5 or 7-6) = 5 points per set

Sets Won by 4 games or more (e.g. 6-2, 6-1, 6-0) = 10 points per set

### **Championship Bonus Points**

Player Wins a Championship = 40 points per championship

Player is Runner Up = 20 points per championship

### **Walkover / Retirement Rules**

Match Win by walkover or Retirement = 20pts

No other stats counted.

Match loss due to retirement or walkover = 0pts

No other stats counted.

### **Powerplays**

The following power plays can be used once per round only and one power play only at a time.

Bench points: players on your bench score points as well as starters

Lucky Loser: your first starter to be knocked out continues to score points by the player who knocked them out.

Double Aces: Aces count double

Captain: your selected captain scores double points

- 10 The Promoter's decisions in relation to all aspects of this Promotion are final and no correspondence will be entered into, including decisions in relation to the number of points that a Participant may have earned.
- 11 Rankings of Participants from the last tournament completed and cumulative rankings for all completed tournament weeks will appear on the Website as per clause 15 below. Rankings on the Website may not give a true indication of the eventual winner of a prize.

### Rounds

- 12 The Promotion is comprised of 6 'tournaments'. Australian Open, French Open, Wimbledon, US Open, WTA Finals & ATP Tour Finals. In order for players to be eligible for each stage, Participants must submit a team by the deadlines displayed on the website.

## Privacy

- 13 The Participant agrees that the Promoter will personal information (as specified in paragraph 4) in order to conduct the Promotion, to assist in providing the goods or services the Participant has requested, to process Participant Promotion entries, to improve the Promoter's products and services, and as otherwise contemplated under these terms and conditions and the Promoter's privacy policy located at [www.ne14tennis.co.uk](http://www.ne14tennis.co.uk), which contains information about how Participants may access and seek correction of their personal information or complain about a breach of their privacy, and how the Promoter will deal with that complaint. The Promoter is bound by the *Privacy Act 1988* (Cth). By entering the Promotion, Participants consent to their personal information being used in the manner set out above. If you do not agree, you must not provide your personal information, and you will be unable to enter the Promotion.
- 14 Where the Promotion is communicated on Facebook, Twitter or any other third party platform, participants in the Promotion acknowledge that the Promotion is in no way sponsored, endorsed or administered by or associated with Facebook, Twitter or such other third party platform and participants in the Promotion release Facebook, Twitter and such other third party platform and their associated companies from all liability arising from the Promotion. Participants in the Promotion acknowledge and agree that they are providing their information to the Promoter and not to Facebook, Twitter or any such other third party platform. Any questions, comments or complaints about this Promotion must be directed to the Promoter and not to Facebook, Twitter or such other third party platform.

## Discontinuance and Disqualification of Promotion

- 15 The Promoter reserves the right to discontinue the Promotion at any time and at its sole discretion may cancel, terminate, suspend or modify the Promotion as of right and without need for a court decisions and/or, if necessary, to provide an alternative prize or prizes to the same value as an original prize or prizes. Any change to or cancellation of this Promotion, for whatever reason, is subject to applicable law.
- 16 Without limiting the foregoing, the Promoter reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of the Promoter, can be considered objectionable, profane, potentially insulting, inflammatory or defamatory, or any entrant whose entry is not compliant with these terms or who has, in the opinion of Promoter, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promotion and/or Promoter. The Promoter reserves the right in its sole discretion to disqualify and individual who the Promoter has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.

## Prizes

- 17 The player with the highest score of each round will receive a £10 Amazon Gift Card. The player with the overall highest score for the 6 rounds will receive 2 tickets to the 2022 Nature Valley Classic at Edgbaston Priory Club. If for covid reasons this is not possible tickets for 2023 will be issued instead. The runner up of the overall competition will receive a NE14 Tennis custom hoodie in a size and colour of their choice. NE14 Tennis has the right to change these prizes if required.
